

VILLAGE OF THORSBY  
BY-LAW # 2013-08

**BEING A BY-LAW TO PROVIDE FOR THE IMPOSITION OF PENALTIES ON UNPAID MUNICIPAL TAXES**

WHEREAS the Municipal Council of the Village of Thorsby in the Province of Alberta, pursuant to the provisions of the Municipal Government Act Chapter M-26.1 and amendments thereto, deems it expedient to impose penalties on unpaid taxes;

NOW THEREFORE the Council of the Village of Thorsby in the Province of Alberta enacts as follows:

1. Municipal taxes shall be due and payable in full on the last business day of June in each calendar year.
2. In the event of any current years taxes remaining outstanding after the due date, a penalty of 6% of the unpaid amount will be levied the first business day following the due date. A 2% penalty will be applied to outstanding current taxes at the 1<sup>st</sup> of each month from August to December.
3. A penalty of 12% shall be applied to all taxes in arrears on January 1 of each year.

By-Law #2009-07 is hereby repealed.

TOWN OF THORSBY  
BY-LAW # 2020-04

**BEING A BYLAW OF THE TOWN OF THORSBY, IN THE PROVINCE OF ALBERTA, TO AMEND BYLAW #2013-08 PROVIDING FOR THE IMPOSITION OF PENALTIES ON UNPAID TAXES.**

WHEREAS the Municipal Council of the Town of Thorsby in the Province of Alberta, pursuant to the provisions of the Municipal Government Act Chapter M-26.1 Sections 344, 345, 346 and 347 and amendments thereto, deems it expedient to impose penalties on unpaid taxes;

WHEREAS the Town of Thorsby wishes to extend relief to property owners for the 2020 year only, resulting from the Covid-19 pandemic and subsequent economic effects;

NOW THEREFORE the Council of the Town of Thorsby in the Province of Alberta enacts as follows :

- 1.1 For the 2020 tax year only, Municipal taxes shall be due and payable in full on the last day of July.
- 2.1 For the 2020 tax year only, deferment of payment may be made until the last day of August, in the event of any current year's taxes remaining outstanding after August 31, a penalty of 6% of the unpaid amount will be made the 1st day of September
- 2.2 For the 2020 tax year only, a 2% penalty will be applied to outstanding current taxes at the 1<sup>st</sup> of each month from October to December
